A Resolution and Notice Discontinuing a Public Way in the Town of Mentor

The Town Board of the Town of Mentor, Clark County, Wisconsin, by this resolution, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, resolves and declares as follows:

The public way described below is vacated and discontinued pursuant to Wis. Stats. § 66.1003 (4). It is in the public interest that the public way described below is vacated and discontinued pursuant to Wis. Stats. § 66.1003 (4). The public way to be discontinued is described as follows:

That portion of Main Street abutting and lying west of Lot 1 being Lots 20 through 32 of Block H of the West Wisconsin Railway Company Addition to Humbird lying between Halsted Street to the north and Carter Street to the south.

The discontinuance of the above-described public way will not result in a landlocked property and no owner of property abutting the discontinued public way will be damaged by the discontinuance. The discontinued public way will be vacated and the land awarded to the Town of Mentor who is the only owner of real estate abutting the discontinued way.

A public hearing to discuss a proposed action to discontinue a public way in the Town of Mentor shall be held as provided in accordance with the following Notice of Hearing.

The Town Clerk shall publish the following Notice of Hearing as a class 3 notice under Wis. Stats. Chapter 985, and the Town Clerk shall cause the Notice of Hearing to be served on the owners (if any) of all of the frontage of lots and lands abutting upon the public way sought to be discontinued in the manner provided for the service of summons in circuit court at least 30 days

before the hearing, except that when service cannot be made within the town, a copy of the notice shall be mailed to the owner's last-known address at least 30 days before the hearing:

A public hearing will held be held by the Town Board of the Town of Mentor at Town Hall on April 14, 2010 at 6.30 p.m., to discuss a proposed action to commence discontinuance of the following described town road initiated by introduction of a resolution by the Town Board of the Town of Mentor pursuant to Wis. Stats. § 66.1003 (4), specifically:

That portion of Main Street abutting and lying west of Lot 1 being Lots 20 through 32 of Block H of the West Wisconsin Railway Company Addition to Humbird lying between Halsted Street to the north and Carter Street to the south.

The Town Clerk shall file in the Office of the Register of Deeds for Clark County, Wisconsin, a Lis Pendens related to the proposed discontinuance of public way.

The Town Clerk shall properly post or publish this resolution as required under Wis. Stats. § 60.80.
