MINUTES

Chairman Gile called the meeting to order.

All Board members were present.

Pledge to Allegiance

Verification of posting in 3 places.

Previous month's minutes were read. Supervisor Two, Robert Dobson made a motion to accept previous month's minutes without any additions or corrections. Supervisor One, Carol Johnson 2nd the motion. Motion Carried.

Correspondence: Election Training December 7, 2015 at the Neillsville American Legion Hall.

Due to the former chairman, the town will be paying legal fees. A complaint was filed with the Clark County District Attorney and stated that the Budget Meeting was not published in the appropriate time frame. The District Attorney contacted the town board and told them to contact their Town's Attorney and have this resolved before the Budget Meeting. Clerk signed an Affidavit stating were the notices were posted. Wis. Stat. § 65.90 states the towns can post notices in three place OR publish. Town choose to post notices of the Budget meeting in three places. The Town published one week in the Shopper as just a reminder. Same issue arose in 2013.

Treasurer Report was read. Supervisor Two, Robert Dobson made a motion to approve this month's bills, starting with check number 13439 to 13460. Supervisor One, Carol Johnson 2nd the motion. Motion carried.

Cathy Wrycza, Sales Representative from WE Energies, discussed the natural gas line that is being installed in the Village of Humbird.

Chairman Gile asked the Board if he could move the Agenda. Board approved.

Emmanuel D'Huyvetter requested permission from the town board to cross on Hart Road. Possibility two locations to run drain tile. The board gave permission with the condition he repairs Hart Road back to his original condition.

Supervisor Two, Robert Dobson made a motion to change the Main Street Bridge from a 20 ton bridge to 5 ton bridge. Supervisor One, Carol Johnson 2nd the motion. Motion carried

Update of the Labor Day storm damage: Dam work is done, All the Roads are done, except paving the patches which will be done next year.

Website: Supervisor One, Carol Johnson made a motion to give permission to Chairman Gile and the Clerk, Linda Laffe, to meet with Jack Ikhtiari of Kamduke Web Designs and to go over the Web Site for the Town of Mentor. If Chairman Gile thinks the Web site is ready, it will go public. Supervisor Two, Robert Dobson 2nd the motion. Motion Carried.

Supervisor Two, Robert Dobson made a motion to adopt Ordinance 124 to Total Opt Out of Any Length and Weight Limits for, ALL Ag CMVs and for any trailing of one of these two types of vehicles from farm to field, from field to field, or from farm to farm, pursuant to §348.15 (9)(f) 2. Supervisor One, Carol Johnson, 2nd the motion. Motion Carried.

The new hours for the Clerk office will be Monday, Wednesday, and Friday from 9:30 am to 1:30 pm. Chairman Gile stated to be reasonable about the Clerks hours because she is back to work for the school district and she transport a student to Eau Claire every day.
